

NOTICE OF RACE Amendment 1 Forefathers Races in Honor of Bob Cooke & Neil Underwood Saturday, August 19, 2023

- 1 **RULES:** This race will be governed by the *rules* as defined in the *Racing Rules of Sailing* (RRS).
- 2 FLEETS & CLASSES: Double-handed crews, ie, one skipper and one crew, are eligible to enter The Bob Cooke Memorial race. Boats with 3 or more persons aboard are eligible to enter the Neil Underwood Memorial race. Class options in both races include spinnaker, nonspinnaker, and J24, depending on race entries. The RC may combine classes with fewer than 3 entries as well as assign temporary ratings for boats without a current PHRF rating.
- **3 RACE ENTRY & FEES**: Race entry, payment of fees, and access to race documents are available online only. The entry fee is \$35, which is discounted by \$5 for members of CIYC and/or US Sailing Association. - **5 RACING AREA**: The race will start and finish **in the vicinity of the Channel Islands Harbor Entrance**. Random leg course options **less than 20nm** will be included in the Sailing Instructions.
- **6 PRIZES**: Individual prizes will be awarded after racing. Perpetual trophies for the Bob Cooke and Neil Underwood races will be engraved with the names of the winning boats and displayed at Channel Islands Yacht Club.
