Notice to Competitors #2

Amendment #2 to the Notice of Race

In NOR 1, add the following:

- 1.2 The Class Rules of the International Hobie Class Association apply.
- 1.3 The US Sailing prescriptions to the following *rules* apply: Introduction, 25.1, 34, 60.3, 61, 63.1, 63.2, 67, 70.5(a), 76.1, 81, 88.2 and Appendix R. These are stated in English in NOR Addendum 1 (separate document), which will be available at <https://regattanetwork.com/event/27351>, and will be posted on the official notice board at Roton Point.
- 1.4 Notation '[NP]' denotes a rule for which a boat may neither protest another boat for breaking that rule, nor request redress based on the rule. The protest committee may refuse to hold a hearing. **This changes RRS 60.1(a), 60.1(b) and 63.1.**

Reason: 1.2 and 1.4 added at the request of the IHCA; 1.3 added per RRS J2.2(2).

Revise NOR 2.1 to read as follows:

- 2.1 The sailing instructions will be available on 12 Sep 24 at <https://regattanetwork.com/event/27351>, and will be posted on the official notice board at Roton Point.

Reason: Clarification.

Revise NOR 7.1 to indicate that Check-In will be open on Sunday afternoon and Monday morning ONLY. No change to Measurement schedule.

Reason: Request from the OA.

Revise NOR 7.2 to indicate that no lay days will be scheduled.

Reason: Request from the Class Association.

Add the following, and renumber the remaining sections.

11 PENALTY SYSTEM

- 11.1 RRS 44.1 is changed so that the One Turn Penalty replaces the Two-Turns Penalty.
- 11.2 In RRS 44.2 insert after the first sentence: "However, if Mark O is set, a boat may take a penalty for an incident in the Zone around Mark 1 or on the leg between Mark 1 and Mark O, as soon as possible after leaving the Zone around Mark O".
This changes RRS 44.2.
- 11.3 The penalty, if any, for an infringement of a class rule will be at the discretion of the Protest Committee [which will be guided by the IHCA Class Rule Penalty Policy, at <https://hobieclass.com/class-rules>], and may be other than disqualification. **This changes RRS 64.2.**

Reason: 11.1 added per the Class Rules. 11.2 and 11.3 added at the request of the Class Association.

12 [NP] CHARTERED OR LOANED BOATS

- 12.1 Boats are not available for charter or loan through the OA.
- 12.2 For the avoidance of doubt, boats privately chartered or loaned are not eligible for redress due to breakdowns.

Reason: Clarification.

Add [NP] notation to NOR 4.5, 6, 8 and 12.
