NOTICE OF RACE

This is a brand new event! Race management and equipment provided by DIYC, support vessels and hospitality provided by VYC.

1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*, including Appendix V2 (Post-Race Penalties).
- 1.2 The event is organized by Davis Island Yacht Club and Venice Yacht Club.

2 ELIGIBILITY AND ENTRY

- 2.1 The regatta is open to all boats with a valid WFPHRF certificate, or a temporary rating assigned by the DIYC Club Measurer.
- 2.2 Expected Divisions are Spinnaker (A/B), Racer-Cruiser, and Cruising.
- 2.3 Under West Florida PHRF rules, this is a Category 2 event.
- 2.4 The minimum crew, including the skipper, shall be two persons.
- 2.5 Cruising spinnakers are permitted for the Cruising Division. All Cruising boats intending to use a cruising spinnaker must declare so by email to SailingSecretary@diyc.org at least two days prior to the event.
- 2.6 Boats shall enter on-line at the Racing/Regattas page at <https://www.regattanetwork.com/event/28289> Entries close at 1700 on October 10. Late entries may be accepted at the sole discretion of the Organizing Authority.
- 2.7 All boats shall carry a workable VHF radio capable of receiving and transmitting on channels 16 and receiving weather broadcasts. A mobile phone is also recommended on each boat.

3 FEES

- 3.1 The entry fee is \$75.25 (\$70.00 plus 7.5% tax). Entry fees are non-refundable.
- 3.2 Registrations received after October 5th must add a late fee of \$20 plus tax.
- 3.3 Entry fee includes beer and appetizers (chips) at the Friday Welcome Party, grab-n-go breakfast Saturday morning at VYC, and one (1) dinner ticket for Saturday night. Additional Saturday dinner tickets may be purchased for \$30.00 (\$27.92 plus 7.5% tax).

5 SAILING INSTRUCTIONS

The sailing instructions will be available on the DIYC website, and at check-in.

6 COURSE

- 6.1 The Race to Venice race will begin at Big-J in Tampa Bay and the finish will be off Venice Inlet. Sailing Instructions will go into further details.
- 6.2 Saturday’s race will be defined in the Sailing Instructions, but will be one Distance RLC race using drop-marks.

7 PENALTY SYSTEM

All Divisions will use the Scoring Penalty of RRS 44.3.

8 SCORING

- 8.1 All Divisions will be scored TOD using West Florida PHRF RLC ratings.
- 8.2 There will be no scores excluded from the event.

9 PRIZES

Prizes will be awarded in each Division for first place, if 1-3 boats; top two, if 4-5 boats; top three, if 6 or more boats. Separate prizes for Friday’s race and Saturday’s race. There will be a combined overall award on a perpetual trophy for each Division.

10 DOCKAGE

- 10.1 For dockage at DIYC up to one week before the event, please contact/text DIYC Dockmaster Chris Toro at 727-222-7561 for first come, first serve slips. Fees may apply beyond reciprocal privileges.
- 10.2 Boats will be able to dock at Venice Yacht Club. Contact Jeff Towers at 941-483-3625.
