## 2024 JIMMY ROGERS MEMORIAL RACE

June 15, 2024

### NOTICE OF RACE:

The Organizing Authority for the 2024 Jimmy Rogers Memorial Regatta will be: The Point Loma Yacht Club / (PLYC)

#### 1 RULES

The race will be governed by the rules as defined in The Racing Rules of Sailing. This race is an open event utilizing San Diego PHRF handicaps.

#### 2 ELIGIBILITY AND ENTRY

The regatta is open to all members of organizations affiliated with US Sailing. Only sailboats that are capable of self-rescue are allowed. All eligible boats must enter on-line at [Jimmy Rogers Memorial Race : Point Loma Yacht Club \(regattanetwork.com\)](http://regattanetwork.com) no later than 1500 on Friday, June 14, 2024. Late entries will not be accepted without donation of a bottle of Jameson.

#### 3 FEES

3.1 \$28 fee for all entries who are not members of Point Loma Yacht Club.

3.2 \$10 fee for members of Point Loma Yacht Club, or for Martin 16s from CSSD.

#### 4 CLASS BREAKS AND CLASS PENNANTS

Schedule, Class Flags, Classes and Starting Order: One race is scheduled. The scheduled time of the warning signal for the first class is 1155. The classes are non-spinnaker, spinnaker, and Martins. The starting order is as follows: Spinnaker class will start at noon, and non-spinnaker class will start at 1205, Martins start at 1210. Spinnaker class #1 flag (red/white), Non-spinnaker class #2 flag (blue/white), Martins no flag needed.

#### 5 SAILING INSTRUCTIONS

Will be posted on Regatta Network by Fri, June 14, 2024 2000hrs.

#### 6 VENUE AND COURSE

The race will commence in the Harbor Island area and extend out past the bay entrance. **RC Boat** will be on station, or alternatively on shore, just off the mid-point of Harbor Island, and the course will be directly to SD1 rounding SD1

to Port and return to the finish/start line. **Course Length 14 NM.** Martins will sail to SD17 (rounded to port) and back.

## 7 PENALTY SYSTEM

7.1 For all classes, the first two sentences of Rule 44.1 are changed to: 'A boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 in an incident while racing or rule 31. However, when she may have broken one or more rules of Part 2 in an incident while in the zone around a mark other than a starting mark, her penalty shall be a Two-Turns Penalty.'

7.2 Appendix T5 Protest Arbitration will apply.

## 8 SCORING

This race will be scored using RLC and San Diego PHRF handicaps and Time Over Distance (TOD).

## 9 RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile devices.

## 10 PRIZES

10.1 Race results will be announced and published on Regatta Network, and announced at the after party at SWYC.

10.2 Race prizes will be awarded at the using a limited process in each class as determined by the Race Committee. See # 8.

## 11 DISCLAIMERS OF LIABILITY

Sailing is an activity that has an inherent risk of damage and injury. Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta. The race organizers (PLYC, race committee, protest committee, host club, sponsors, or another organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor including death, sustained as a result of participation in this event. As a condition of their participation in this regatta, competitors release all claims they may have against PLYC and its officers, directors, members, committees and employees for damage to property, personal injury or death sustained in conjunction with or prior to, during or after the regatta. Competitors shall be responsible for damage or injury caused by their breach of The Racing Rules of Sailing or applicable governmental rules for the avoidance of collision.

## 12 POST RACE ACTIVITIES

There will be an after-race activity at Southwestern Yacht Club in the bar area, at approximately 330 PM following the finish of the race.
