Event Date: Saturday, July 14, 2024

1 Rules

1.1 This regatta will be governed by the Rules as defined in the Racing Rules of Sailing (RRS), this NOR, and the SSC Standing Sailing Instructions. If there is a discrepancy between this NOR and the SSC Standing Sailing Instructions, the NOR shall govern.

2 Eligibility

- 2.1 This event is open to all yachts that meet the Northern California PHRF minimum requirements, and have a NC PHRF, or Stockton Sailing Club PHRF rating. In the event that identical boats rate differently under the two rating systems, the Stockton Sailing Club ratings will apply.
- 2.2 This event is open to Stockton Sailing Club member yachts crewed by not more than two (2) individuals of mixed gender.

3 Entries

- 3.1 The entry fee is \$10. Register online on the Regatta Network event site by midnight on Saturday, July 13th: https://www.regattanetwork.com/event/28378
- 3.2 Or, submit a registration form to the Regatta Committee mailbox in the clubhouse by midnight on Saturday, July 13th. Registration forms are available in the clubhouse.
- 3.3 Entries will be accepted until 1130 on Sunday but will incur a late fee of \$5.00

5.1 Starting signals will be made in accordance with Racing Rules of Sailing Rule 26.

Notices on race day will be posted on the notice board/window left of the main clubhouse entrance facing the harbor no later than 30 minutes before the first warning signal.
