

Jazz Cup 36 - August 31, 2024

Sailing Instructions

1. Rules:

- 1.1. The race will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2. Appendix V1 and V2 will apply.

2. Communications with Competitors

- 2.1. Changes to the Sailing Instructions and any notices to competitors will be posted by 1700 hours on August 30, 2024, on the Jazz Cup ONB (Official Notice Board) https://www.regattanetwork.com/event/28520
- 2.2. Notices to competitors after the finish will be posted on the ONB, in the Regatta Room, on the first floor of BYC, located on the wall opposite the first-floor bar (near the restroom doors).
- 2.3. Communications with the race committee shall be made on VHF channel 78.

3. Check-In:

3.1. Boats are required to check in by radio between 0950 and 1050 hours on VHF channel 78. No radio check in will be accepted after 1050 hours. When checking in, please give only your division and sail number.

4. The Course:

4.1. The course is described as:

Start, R"12" (starboard), Red Rock Island (starboard), Temp A (port), Temp B (port), Finish.

See starting area and finish area charts below.

5. Description of Marks:

- 5.1. R "12" FI R 2.5s approximately 1.7 nm WSW of the Richmond Chevron Long Wharf (chart 18653)
- 5.2. Red Rock Island LAT 37° 55.751' N LON 122° 25.839' W (chart 18653)
- 5.3. Temp A A temporary tetrahedron buoy approximately .5 nm ENE of G "25" (chart 18656). See finish line chart below
- 5.4. Temp B A temporary tetrahedron buoy approximately 0.3 nm North of Temp A, between Temp A and the shore. See finish line chart below.

6. The Start:

6.1. The Starting Line will be between a staff displaying an orange flag on the Signal boat and the course side of an inflatable mark located approximately .7 nm South of Red Rock Island. The approximate coordinates of the Signal boat will be:

LAT 37° 55.0549' N LON 122° 26.0598' W

6.1.1 The first warning is scheduled for 1100 hours.

6.2. Starting Order:

The warning signal for each succeeding class shall be the starting signal of the preceding class **(rolling starts)**. In the event of a General Recall, rolling starts will resume following the recall.

Starting Order and Division (Division Flag):

6.2.1. Division D	Non-Spinnaker All Boats	D (Delta)
6.2.2. Division E	Spinnaker 166 and above	E (Echo)
6.2.3. Division F	Spinnaker 130 to 165	F (Foxtrot)
6.2.4. Division G	Spinnaker 120 to 129	G (Golf)
6.2.5. Division H	Spinnaker 90 to 119	H (Hotel)
6.2.6. Division O	YRA defined Sport Boats	O (Oscar)
6.2.7. Division J	Spinnaker 70 to 89	J (Juliet)

6.2.8. Division K Spinnaker 69 or less K (Kilo)

6.2.9. Division U Multi-Hull U (Uniform)

7. Recalls:

7.1. Individual: The Race Committee may hail the sail number of the boat(s) identified on the course side of the starting line at the starting signal. Failure of a hail, failure to hear the hail or the order of the hails shall not be grounds for redress. This changes RRS 62.1 (a).

8. The Finish:

- 8.1. The Finishing Line will be a line from a staff displaying a blue flag on the dock ashore Sander's Pier and an inflatable mark east of the entrance to Benicia Marina. See finish line chart below.
- 8.2. Boats retiring before finishing shall notify the Race Committee as soon as practical either on VHF 78 or by phone message or TXT message to Dan Courter (PRO) 925-209-3081.

9. Areas that are Restricted:

- 9.1. For safety, each of the following areas is an obstruction:
- 9.1.1. Competitors shall not cross into the Pinole Channel. Lines connecting the Pinole Channel buoys along the North side and the South side shall be considered obstructions.
- 9.1.2. All prohibited areas described in 33 CFR 165.1181 for San Francisco Bay: https://www.law.cornell.edu/cfr/text/33/165.1181

Boats are prohibited from sailing into those areas while racing.

10. Time Limit:

- 10.1. Boats that do not start within 4 minutes of their division start will be scored "DNS".
- Boats that do not finish by 1915 hours will be scored "DNF" without redress. This
 modifies RRS 35.

11. Hearing Requests (protests/request for redress):

11.1. For each class the protest time limit is 60 minutes after the last boat has finished in the class.

11.2. The time and place of all protest hearing(s), the boat(s) being protested and the boat(s) requesting redress will be posted on the Official Notice Board at the Benicia YC. It is each boat's responsibility to check the Official Notice Board in a timely fashion to see if they are a party to a protest or redress hearing. This shall serve as proper notification per RRS 63.2. All protest meetings will be held via ZOOM, not in person.

12. Scoring:

12.1. PHRF Time-on-Time correction will be used. Corrected times will be calculated to the nearest second.

13. Awards:

13.1. Awards will be handed out on the day of the race at the Benicia Yacht Club after 2000 hours. At the discretion of the race committee, some awards may be mailed to the winning skippers.

14. Disclaimer of Liability:

Boats and competitors compete in the regatta entirely at their own risk; see RRS 3 - Decision to Race.




