



NOTICE OF RACE Posted 12/10/24; Amended 1/23/25

RULES:

- The Organizing Authority is Coconut Grove Sailing Club and Miami Snipe Fleet #7.
- The regatta will be governed by the rules as defined in the Racing Rules of Sailing ("RRS").
- The following Prescriptions of US Sailing are the only Prescriptions that will apply: Appendix R, the prescription to the preamble to Part 5, and the prescriptions to rules 65.1, 70.3(b), 76.1 and 88.2.
- Each Snipe racing in this event must have aboard life-saving equipment conforming to government regulations in either the USA or the home country of each of the sailors aboard.
- The following Rules may be amended in the Sailing Instructions: RRS 27.1; RRS 30.4; RRS 32; RRS 33; RRS 35; RRS 44.3(c), RRS 61.2(b); RRS Appendix A2; RRS Appendix A4; RRS Appendix A5; RRS Appendix A10; and RRS Race Signals .

ADVERTISING: Advertising is permitted as per Snipe Class Rules. Boats may be required to display advertising chosen and supplied by the organizing authority.

ELIGIBILITY

AND ENTRY: The regatta is open to SCIRA registered boats and Class Member skippers who are in good standing with SCIRA for the current year. Boats shall enter the Regatta by completing the on-line registration and paying the entry fee on the event website,
