- 1 RULES:** This race will be governed by the *rules* as defined in the *Racing Rules of Sailing* (RRS).
- 2 FLEETS & CLASSES:** The Bob Cooke Memorial Race is a Double-Handed race, ie, one skipper and one crew. The Neil Underwood Memorial race Boats with 3 or more persons aboard. Class options in both races include spinnaker, non-spinnaker, and J24, depending on race entries. The RC may combine classes with fewer than 3 entries as well as assign temporary ratings for boats without a current PHRF rating. However, boats without a current PHRF certificate are not eligible for individual or perpetual trophy awards.
- 3 RACE ENTRY & FEES:** Race entry, payment of fees, and access to race documents are available online only. The entry fee is \$35, which is discounted by \$5 for members of CIYC and/or US Sailing Association. - 5 RACING AREA:** The racing area will be the coastal waters of Ventura County. The race will begin near the Mandalay race buoy and finish in the same area. Random leg course options up to 19.5nm off the Ventura County coast will be included in the Sailing Instructions.
- 6 PRIZES:** After racing, individual prizes will be awarded among boats with current PHRF ratings. Perpetual trophies for the Bob Cooke and Neil Underwood races will be engraved with the names of the winning boats and displayed at Channel Islands Yacht Club.
