NOTICE OF RACE

1 RULES

1.1 The regatta will be governed by the rules as defined in the 2021 – 2024 Racing Rules of Sailing, the attached waiver and release of liability, and the attached official entry form.

1.2 Racing Rules of Sailing Part 4 preamble and RRS 40 will be changed as follows: When flag Y is displayed ashore, all competitors and crew shall wear personal buoyancy at all times while afloat except for brief periods (two 2 minutes or less) while changing or adjusting clothing or personal equipment.

2 ENTRY FEE

The Drew Bowl Regatta entry fee will be \$50 per Boat. Online registration to be provided shortly.

5 THE COURSE

The courses shall be Olympic courses, Triangles or Windward Leewards at the discretion of the race Committee. The Course board will display an O for Olympic, a T for Triangle and W for Windward Leeward. For Triangles and Windward Leewards there will be a number displayed that will designate the number of Windward Legs. All Races will finish to windward.

6 SCORING

The number of scheduled races is four (4) of which one (1) must be completed to constitute the regatta. Should wind, weather, or other conditions make it impossible or impractical to complete all four (4) races within the publicized time, the event will be terminated and the results will be based upon the completed number of races. There will be one drop race if four (4) races are completed.

7 RADIO COMMUNICATIONS

A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

8 REQUIRED SAFETY EQUIPMENT

Paddle, 50 ft. line & PFD

8.1 US Competitors shall carry a U.S. Coast Guard (USCG) approved personal floatation device (PFD).

9. AWARDS

Drew Bowl Perpetual Trophy - 1st Overall

Pasadena Perpetual Trophy - 1st in last Race

First through third places will receive trophies for skipper and crew.

10 LAUNCHING AND BERTHING

Lift launching is available.
