## HARBOR PURSUIT RACE

## October 19, 2024

## NOTICE OF RACE

**<u>Rules</u>**: This regatta will be governed by the current Racing Rules of Sailing, the rules of the classes sailing, the Sailing Instructions and this Notice of Race. Double headsails for non-spinnaker classes and non-spinnaker boats in spinnaker classes are allowed.

**<u>Eligibility</u>**: This regatta is open to members of SCYA recognized Yacht Clubs and Sailing Associations. YACHTS RACING MUST HAVE A CURRENT PHRF RATING. PHRF Area "C" RLC ratings will be used for scoring. The following classes are invited to participate: PHRF: Spinnaker and Non/Spinnaker with Non/Spin offset.

<u>Entries</u>: Entries may be on the form below and must be accompanied by a check for the amount of the entry fee made payable to Seal Beach Yacht Club or you may enter online at: <u>https://www.regattanetwork.com/event/28747</u>. Paper entries may be mailed to RACE CHAIRMAN, Seal Beach Yacht Club, 255 Marina Drive, Long Beach, CA 90803 or placed in the Race Entry Box at the Seal Beach Yacht Club. All entries must be received by 1700 on October 18, 2024.

**Entry Fee:** Entry fee is \$20.00 if submitted by October 17, 2024 and \$30.00 if submitted after October 17, 2024.

<u>Class Breaks</u>, <u>Starting Times and First Warning</u>: Start times and class breaks will be posted at the Club by 1000, October 19, 2024. First warning will be at 1255 on October 19th. First start will be at 1300 on October 19, 2024.

Sailing Instructions: Shall be posted no later than 1800 October 18, 2024.

<u>Course #1</u>: Code flag 1 will be displayed. The race will begin near mark 38. Take Los Angeles entrance (Mark 50) to port; take East End Long Beach Breakwater (Mark 10) to port; pass "A" Buoy at entrance to Alamitos Bay to port (if the "A" Buoy is missing, the last mark of the course and the beginning of the continuous obstruction will be the first center of channel buoy); and finish in Alamitos Bay between the Navy Yacht Club and the 5 mile per hour buoy near the fuel dock. When entering the channel, the head of the spinnaker and/or second headsail shall be on or below deck level before the yacht's bow crosses between the <u>ENTRANCE LIGHTS</u> to the Alamitos Bay jetty. A straight line connecting adjacent channel marker buoys within the Alamitos Bay jetty shall be considered a continuous obstruction in accordance with Racing Rule 19.2. <u>NO YACHT MAY CROSS SAID LINE.</u> Handicap distance is 13.8 mi.

**Course #2**: Code flag 2 will be displayed. The race will begin near mark 38. Take mark 37 to starboard; take Mark 27 (Buoy R "2" – near pier J) to port; take Queens Gate (Mark 13) to port; Platform Esther to Port; pass "A" Buoy at entrance to Alamitos Bay to port (if the "A" Buoy is missing, the last mark of the course and the beginning of the continuous obstruction will be the first center of channel buoy); finish same as long course. Handicap distance is 9.0 mi.

<u>**Time Limit:**</u> The race shall be called at 1730. A yacht finishing prior to 1730 shall establish the race for its class. No yachts will be finished after 1730.

**Protests:** See the Sailing Instructions.

<u>Trophies</u>: Harbor Pursuit Race class and overall trophies will be presented at Seal Beach Yacht Club on October19<sup>th</sup> as soon as possible after the last boat finishes. The number of trophies for this race will be based on the number of yachts entered in each class by 1800 October 15, 2024: 1- 4 boats (1); 5-8 boats (2); 9-11 boats (3); 12-14 boats (4); 15 or more boats (5). Trophies not claimed within 60 days shall remain the property of Seal Beach Yacht Club.

WAIVER, RELEASE AND INDEMNIFICATION: To the fullest extent permitted by law, I waive all claims, forever release and agree to indemnify and hold harmless Seal Beach Yacht Club (SIBYC), its owners, affiliates, officers, directors, members, employees, agents, committee persons, and race officials, acting in their official capacities, both jointly and severally from any and all damages, injury, liability, loss, cost or expense, including attorney fees, to any persons and/or property arising from my or my crew's actions and/or participation in the race, including SIBYC's active or passive regular negligence, but not willful misconduct or gross negligence.

7. ASSISTANCE: Any assistance provided by SIBYC race committee vessels and personnel will be at the risk of the participants.

8. PHOTO RELEASE: I hereby grant to SIBYC and its representatives the right to take photographs and videos of me and/or my boat in connection with this regatta. I authorize SIBYC to copyright, use and publish these images in print and/or electronically.
