1. RULES

- 1.1. The regatta will be governed by the rules as defined in *The <u>Racing Rules</u> of Sailing*, except <u>US Sailing Prescriptions</u> to Rule 63.2 will not apply.
- 1.2. Day Sailer class Rules will also apply.

2. SAILING INSTRUCTIONS (SI) AND COURSES

- 2.1. The Sailing Instructions will be available at MBYC day of race
- 2.2. Information in the Sailing instructions supersedes the NOR

3. COMMUNICATION

- 3.1. Harbor Cup as posted on the MBYC 2024 calendar.
- 3.2. Regatta Forms and Instructions may be posted through Regatta Network
- 3.3. On the water, the race committee will make courtesy broadcasts to competitors on VHF radio channel 69

4. ELIGIBILITY AND ENTRY

- 4.1. As stated in the Deed of Gift, this regatta is open to the one design class chosen for participating in the most races during the year. This years one design is the **Day Sailer** class.
- 4.2. All Racers MUST enter through Regatta Network to be scored.

5. SCHEDULE

- 5.1. HARBOR CUP October 12, 2024
- 5.2. The skippers meeting is scheduled for **10:30** on day of racing.
- 5.3. The scheduled time of the warning signal for the first race is **12:00**.
- 5.4. Five races are planned depending on conditions of the day
- 5.5. No warning signal after 15:30

6. VENUE

- 6.1. The racing area will be Morro Bay Harbor. The course sheet will be in the Sailing Instructions.
- 6.2. The start and finish lines to be located off the south T pier.
- 6.3. The starting area will be determined by the Sailing Instructions

7. SCORING

7.1. Races will be scored using a Low Point System (2021-2024 RRS)

8. AWARDS CELEBRATION

- 8.1. Post-race events will occur at MBYC Club House.
- 8.2. Regatta prizes will be awarded for the days results: 1st, 2nd & 3rd
- 8.3. The HARBOR CUP Perpetual Trophy will remain at MBYC
