SAILING INSTRUCTIONS(SI) Revision #1

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1.

The notation '[DP]' in a rule in the NoR or SI means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification. This changes RRS 64.

1. RULES

- 1.1. The event is governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2. US Sailing Prescription Appendix V ALTERNATIVE PENALTIES shall apply
- 1.3. J/105 Class Rules available at https://www.J105.org will apply.

2. NOTICES TO COMPETITORS

- 2.1. Notices to competitors will be posted on the official notice board located at https://www.regattanetwork.com/event/29206#_newsroom and will also be posted on the glass windows on both sides of the south poolside foyer entrance at Lakewood Yacht Club (LYC). Failure to post a physical notice will not be grounds for redress. This changes RRS 61.4(b)(1).
- 2.2. The race office is located adjacent to the LYC clubhouse lobby, telephone 281-474-2511, email lyc@lakewoodyachtclub.com.

3. CHANGES TO SAILING INSTRUCTIONS

- 3.1. Any change to the sailing instructions will be posted before 1000 on the day it will take effect, except that any change to the schedule of races will be posted by 1800 on the day before it will take effect.
- 3.2. If necessary, changes to the sailing instructions may be made on the water. The Signal Vessel will signal "come within hail" by displaying Flag L with one sound. Each boat will receive and acknowledge the oral change. These changes will be posted on 2025 J/105 Invitational Boqueron Cup: Lakewood Yacht Club notice board as soon as practicable.

4. CODE OF CONDUCT

4.1. [DP] Competitors and support persons shall comply with reasonable requests from race officials

5. SIGNALS MADE ASHORE

- 5.1. Signals made ashore will be displayed at the LYC Flagpole immediately south of the clubhouse and east of the swimming pool.
- 5.2. When flag AP is displayed ashore, "1 minute" is replaced with "not less than 60





minutes" in RRS Race Signals AP.

6. SCHEDULE OF RACES

7. CLASS FLAGS

7.1. The J/105 Class flag is a flag with the J/105 Emblem.

8. RACING AREA

8.1. The racing area is Galveston Bay West of the Houston Ship channel, north of Eagle Point and south of Red Bluff. See SI Addendum 1.

9. COURSES

- 9.1. The diagram in SI Addendum 2 shows the course, including the approximate angles between legs, the order in which marks are to be passed, and the side on which each mark is to be left. The approximate course length is 0.75-1.5 NM.
- 9.2. In the event mark 2P or 2A are missing, boats will round the remaining mark to port.

10. MARKS

- 10.1. Mark(s) are orange and yellow tetrahedrons, and orange spheres
- 10.2. Marks 1, 2P and 2S are yellow tetrahedrons. Mark 1A will be an orange or red sphere. Course changes for mark 1 made in accordance with RRS 33 will replace the yellow tetrahedron with an orange tetrahedron. Course changes for the Marks 2P and 2S will be made by moving the same yellow tetrahedrons.

11. OBSTRUCTIONS

- 11.1. The following areas are designated as obstructions:
 - 11.1.1. The Houston Ship Channel.
 - 11.1.2.The San Leon Oyster Mitigation Reef encompassed within the following approximate points:
 - 29°32.310'N, 94°56.817'W
 - 29°31.845'N, 94°56.305'W
 - 29°31.387'N, 94°56.738'W
 - 29°31.128'N, 94°57.767'W
 - 29°31.172'N, 94°58.885'W
 - 29°31.463'N, 94°59.115'W
 - 29°32.027'N, 94°58.372'W





12. THE START

- 12.1. Races will be started using RRS 26
- 12.2. The starting line is between a staff displaying an orange flag on the signal vessel at the starboard end and the course side of the starting mark.

13. CHANGE OF THE NEXT LEG OF THE COURSE

13.1. To change the next leg of the course, the race committee will lay a new mark (or move the finishing line) and remove the original mark as soon as practicable. When in a subsequent change a new mark is replaced, it will be replaced by an original mark.

14. THE FINISH

- 14.1. The finishing line is between a staff displaying an orange flag on the RC signal vessel and the course side of a nearby finishing mark. This changes Race Signals.
- 14.2. If the race committee is absent when a boat finishes, she shall report her finishing time, and her position in relation to nearby boats, to the race committee at the first reasonable opportunity.

15. TIME LIMITS

15.1. The Mark 1 Time Limit, Race Time Limit (see RRS 35), and the Finishing Window are as follows:

Mark 1 Time Limit 35 minutes Race Time Limit 90 minutes Finishing Window 20 minutes

- 15.2. If no boat has passed the first mark within the Mark 1 Time Limit, the race will be abandoned.
- 15.3. Boats failing to finish within the Finishing Window and not subsequently retiring, penalized or given redress, will be scored Time Limit Expired (TLE) without a hearing. TLE will be defined as the average score of all boats not Finished and still Sailing the Course at the close of the Finish Window. If fewer than 33% of competitors have Finished within the Finish Window, the race shall be Abandoned. This changes RRS 32, 35, 61.1(a), 61.4(b)(1), A4, and A5.

16. PROTESTS AND REQUESTS FOR REDRESS

- 16.1. Boats wishing to protest shall inform the Race Committee after finishing and before the next race of the day or, if the protest arises from the last race of the day, before leaving the racing area. To inform the Race Committee of its intent to protest the boat must hail the Race Committee on the designated channel, identify the boat to be protested, and receive acknowledgment.
- 16.2. Hearing request forms are available from the race office at the LYC Clubhouse lobby. Requests for hearing are to be filed with the race office and may also be filed electronically at the email address posted on the official notice board.





- 16.3. The protest time limit is 60 minutes after the race committee signals with one sound from the LYC Harbor prior to docking. The time will be posted on the official notice board.
- 16.4. The protest committee will endeavour to post the notice of protests and the hearing schedule within 30 minutes after the close of the deadline for filing protests. Hearings will be held in the protest room, located at the LYC clubhouse, beginning at the time posted.
- 16.5. Notices of protests by the race committee, technical committee or protest committee will be posted to inform boats under RRS 60.2(d).

17. SCORING

17.1. A boat's regatta score is the total of her race scores without exclusion. This changes RRS A2.1.

18. SAFETY REGULATIONS

- 18.1. Prior to the first warning signal each day, each boat is required to check in by passing the stern of the Race Committee Signal Boat on starboard tack and hail her sail number until acknowledged by the race committee. All competitors shall be wearing or holding a Personal Flotation Device at this time.
- 18.2. A boat that retires from a race shall notify the race committee at the first reasonable opportunity.

19. REPLACEMENT OF CREW OR EQUIPMENT

- 19.1. [DP] Substitution of competitors is not allowed without prior written approval of the race committee and in compliance with J/105 Class Rules.
- 19.2. [DP] Substitution of damaged or lost equipment is not allowed unless authorized in writing by the race committee and in compliance with J/105 Class Rules. Requests for substitution shall be made to the committee at the first reasonable opportunity, which may be after the race.

20. OFFICIAL VESSELS

20.1. The race committee signal boat will display the traditional race committee flag (red, fouled anchor on a blue field with white letters "R" and "C", aside).

21. TRASH DISPOSAL

21.1. Trash may be placed aboard official or support person vessels.

22. HAUL-OUT RESTRICTIONS

22.1. Boats shall not be hauled out during the event except with and according to the terms of prior written permission of the race committee. In the case of an emergency, permission may be granted retroactively.

23. DIVING EQUIPMENT AND PLASTIC POOLS

23.1. Underwater breathing apparatus and plastic pools or their equivalent shall not be used around keelboats between the preparatory signal of the first race and the end of the





last race of the event.


24. PRIZES

- Top 3 Skippers of the Gold Fleet (Fleet 17 skippers living in the Houston area)






