NOTICE OF RACE

1. RULES:

- 1.1 The regatta will be governed by the rules as defined in *The 2025-2028 Racing Rules of Sailing (RRS)*.
- 1.2 The US Sailing Prescriptions to RRS 63.2 and RRS 63.4 will not apply.
- 1.3 The current WFPHRF class rules will apply. This is a WFPHRF category 4 event.
- 1.4 This is a pursuit start event.
- 1.5 If there is a conflict between the Notice of Race, Sailing Instructions, RRS or WFPHRF, the Sailing Instructions shall take precedence. This changes RRS 63.7.
- 2. ORGANIZING AUTHORITY: The Bradenton Yacht Club is the organizing authority.
- 3. QUALIFYING SERIES: The race is a qualifying event for the SBYA Boat of the Year Series.

4. ELIGIBILITY AND ENTRY:

- 4.1 The regatta is open to all boats with current WFPHRF ratings.
- 4.2 Eligible boats shall enter online at https://www.regattanetwork.com/event/27563 by completing the registration form, agreeing to the conditions of entry, and paying the entry fee.
- 4.3 Registration closes at 1200 on Friday, February 21, 2025.
- **5. ENTRY FEE:** Non-refundable fee is \$50 and includes breakfast on Saturday and beer Saturday afternoon.

6. SCHEDULE:

Warning Signal Saturday, February 22, 2025 at 955

Awards will be presented 30 minutes following the close of protest time and any meeting of the protest committee.

Individual start times will be online and posted on the Official Notice Board.

Should the race be abandoned for any reason, it may be rescheduled for the following day. Any decision to reschedule will be posted on the Official Notice Board within 1 hour of the abandonment.

7. SAILING INSTRUCTIONS: The sailing instructions will be available online by 1700 on Friday February 21, 2025.

- **8. VENUE:** The start shall be located in lower Tampa Bay in the vicinity of Manatee River Marker R2 and will go around Egmont Key and return. The course's rhumb line is approximately 21.2 nm in length.
- **9. DIVISIONS:** Divisions will be determined based upon the organizing authority based upon the entries received.
- 10. CRUISER CLASS CRUISING SPINNAKERS: The Cruising Classes shall declare their intent to use a Cruising spinnaker by 1200 February 21st, 2025 by email to Bob Armstrong, Regatta chairman at RJA265@aol.com. Use of a Cruising Spinnaker will result in a reduction in the non-spinnaker offset as noted in Appendix E Cruising Class Rules. Your certificate must show your actual Cruising Sail measurements to qualify for use.

11. PRIZES:

Prizes may be awarded to Bradenton Yacht Club following the protest time limit and any protest hearings that me be scheduled that day. If they are not, Bradenton Yacht Club will use other means to get them to the recipients.
