The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1.

1 RULES

- 1.1 The event is governed by the *rules* as defined in *The Racing Rules of Sailing.*
- 1.2 RRS A2.1 is changed as follows: No score will be excluded.
- 1.3 For the J/22 class only, the J/22 Addendum to this NOR, which will be posted on the official notice board. To the extent there are changes to the RRS addressed in the Addendum, those changes apply only to the J/22 class unless specifically addressed otherwise in this NOR or the Sailing Instructions.
- 1.4 The following US Sailing prescription does not apply: prescription to RRS 63.1(b).

2 SAILING INSTRUCTIONS

2.1 The sailing instructions will be available electronically after 2100 on May 14, 2025 by <u>following this link</u>, or by following a link that will be available on the Lakewood Yacht Club website.

3 COMMUNICATION

- 3.1 The official notice board is located online by following <u>this link</u>. Unofficial notices may also be posted on the glass entryway to the Lakewood clubhouse foyer from the pool area.
- **3.2** [DP][NP] All boats shall carry a VHF radio capable of communicating on channels 16, 68, 69 and 72.
- **3.3** On the water, the race committee will make courtesy broadcasts to competitors on VHF radio. The channels will be stated in the SIs.
- 3.4 [DP] From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4 ELIGIBILITY AND ENTRY

- 4.1 The event is open to all boats of the following classes: ORC Spinnaker, PHRF Non-Spinnaker, PHRF Cruising Classic Canvas Spinnaker and PHRF Cruising Classic Canvas Non-Spinnaker, J/22, J/24, J/105, RS21, Sonar, and any other one-design class that forms.
- 4.2 ORC entries must have a valid 2025 <u>ORC</u> rating certificate. PHRF entries must have a valid 2025 rating from <u>PHRF Galveston Bay</u>. The Sailing Instructions will contain further information regarding the handicap method to be used and details regarding its implementation.
- 4.3 Boats may enter the event by registering online by <u>following this</u> <u>link</u> and paying the appropriate fee. Entry is not complete until all Eligibility and Entry requirements, including payment of the applicable registration fee, have been met.
- 4.4 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.5 Registration must be completed <u>including payment</u> no later than 2100 on Monday, May 12. However, late entries will be accepted until 2100 Wednesday, May 14, for an additional late fee of \$50; after that time, late entries will only be accepted at the sole discretion of the Race Committee with a donation to Bay Access in addition to the late entry fee.
- 4.6 The following restrictions on the number of boats apply: A minimum of four (4) boats shall be required in order to constitute a class. The Race Committee may, in its discretion, permit classes with fewer boats and re-assign boats to different classes. See also NOR 16.2.
- 4.7 The skipper and all crew members must submit a Waiver and Release of Liability before the skippers' meeting. Failure to submit a waiver for each crew member will result in the entry being incomplete. Skipper waivers are submitted with the online entry form. Crew waivers are submitted on-line by following this link. A link to the list of all crew members who have submitted waivers can be found here and will also be provided on LYC's website. It is the skipper's obligation to ensure that each crew member is listed in the registration, and that each crew member's waiver is reflected on the waiver list before the Skipper's Meeting to verify that the boat has met the entry requirement. At the sole discretion of the Race Committee, crew waivers may be accepted after the Skippers' Meeting but before the first Warning Signal.

- 5 FEES
 - 5.1 Entry fees are as follows: The entry fee is \$140 for handicap boats and all boats over 24 feet LOA, and \$120 for one-design boats of 24 feet LOA or less. US Sailing members are eligible for a discount of \$5.
 - 5.1.1 The late entry fee is as listed in NOR 4.5.
 - 5.2 Other fees:
 - 5.2.1 Box lunches will be available for \$14 each.
 - 5.3 If paying by credit card, please note that if a refund is later issued, a portion will be retained as a processing fee.

6 ADVERTISING

- 6.1 Competitor advertising will be restricted as follows: As a courtesy to our valued race sponsors, no advertising may be displayed on Lakewood Yacht Club premises without prior written permission of the Race Committee.
- 6.2 [DP] Boats may be required to display advertising chosen and supplied by the organizing authority.

7 SCHEDULE

8 MEASUREMENT

8.1 Each handicap boat shall produce or verify the existence of a valid rating certificate upon request of the Race Committee.

9 VENUE

- 9.1 The event venue is at Lakewood Yacht Club and Galveston Bay.
- 9.2 The racing areas will be in Galveston Bay, between the Houston Ship Channel and the shoreline between Eagle Point and Red Bluff.

10 COURSES

10.1 The courses are expected to be windward / leeward courses using dropped marks typically as described in RRS Appendix S as Course L (except that the finish line may be on the starboard side of the signal vessel). There may be a distance course using fixed and dropped marks for cruising classes. More detail will be provided in the Sailing Instructions.

11 SCORING

- 11.1 The scoring system is as provided in RRS Appendix A, as modified by NOR 1.2.
- 11.2 One race is required to be completed to constitute a series.
- 11.3 Rule A5.3 applies.

12 HAUL-OUT RESTRICTIONS

- 12.1 [DP] Keelboats shall not be hauled out during the event except with and according to the terms of prior written permission of the race committee. This rule does not apply to the RS21 or Sonar classes.
- 13 DIVING EQUIPMENT AND PLASTIC POOLS
 - 13.1 [DP] Underwater breathing apparatus and plastic pools or their equivalent shall not be used around keelboats between the preparatory signal of the first race and the end of the event.

14 RISK STATEMENT

14.1 RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue *racing* is hers alone." By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.**

14.2 PHOTOGRAPHERS AND MEDIA RIGHTS All participants, including, but not limited to competitors, skippers, crew, vessel owners, alike, and their quests who participate in the racing or shoreside events related to the regatta grant Bay Access, Lakewood Yacht Club and their sponsors the irrevocable and unrestricted right and permission in perpetuity, to use their name, image or likeness or that of their vessel for editorial, promotional, educational or race reporting purposes in any and all forms of media, including, but not limited to TV, movie, videos, newspapers, magazines, periodicals, and any electronic form of the internet, or like or similar media. As part of the race registration process, each participant shall execute a waiver and release of liability in favor of Bay Access, Lakewood Yacht Club and their sponsors for the use of the participant's name, identity or likeness, or for the use of the name, identity or likeness of their quests who participate in shoreside events related to the regatta and related events.

15 INSURANCE

15.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$300,000 per incident or the equivalent.

16 PRIZES

- 16.1 Prizes will be given as follows: One trophy will be awarded in classes with three boats; two trophies will be awarded in classes with four or five boats; and three trophies in classes with six to eight boats. More trophies may be awarded in any class at the discretion of the race committee.
- 16.2 Trophies will include shoes or equivalent for skipper and crew of the first-place boat in classes with six or more boats entered. The race committee, in its discretion and subject to availability, may award similar awards for the first-place boat in smaller classes.
- 16.3 The name of the winner of the most competitive class as determined in the discretion of the race committee will be added to the Shoe Regatta Challenge Cup Wheel perpetual trophy. Only spinnaker classes sailing in windward/leeward courses will be eligible.
