**Notice of Race**

**Saturday + Sunday, March 29 + 30, 2025**

## 1. RULES

1.1. The race will be governed by the rules as defined in The Racing Rules of Sailing 2021-2024, including US Sailing Prescriptions and Hawaii Yacht Racing Association [HYRA] Prescriptions unless otherwise amended in this Notice of Race or the Sailing Instructions.

## 2. ADVERTISING

2.1. Advertising shall comply with ISAF Regulation 20. Competitor advertising will not be restricted.

## 3. ELIGIBILITY AND ENTRY

3.1. The regatta is open to all yachts that are members of HYRA member clubs, and other yachts that may be invited by the organizing authorities.

3.2. Eligible yachts may enter via the US Sailing Regatta Network website. Entries will only be accepted using the Regatta Network website <http://www.regattanetwork.com/html/calendar.html>.

3.3. A representative from each competing yacht **shall** attend the skippers meeting to be eligible to race.

## 4. FEES

4.1. Required fees are as follows:

5.1. Pokai Bay is a HYRA Seasons Points race.

## 7. MEASUREMENT

7.1. Yachts competing in the PHRF class must have a valid PHRF rating. If the yacht does not have a rating at the time of the race, a rating may be assigned by the organizing authority.

## 8. SAILING INSTRUCTIONS

8.1. The sailing instructions will be available at the skippers meeting and on Regatta Network.

## 9. COURSE

9.1. Day 1

9.1.1. The start will be near the Ala Wai Harbor. The course may or may not include Diamond Head buoy depending on the winds. Finish will be near the Hawaiian Electric Kahe Power Plant.

9.2. Day 2

9.2.1. The start will be near the Hawaiian Electric Kahe Power Plant. The finish will be near the Ala Wai Harbor entrance.

## 10. SCORING

10.1. Corrected times will be calculated using the PHRF Time-on-Time scoring system, as adopted by HYRA.

10.2. The low point system of RRS shall apply.

## 11. BERTHING

11.1. Competing boats are encouraged to raft up in Pokai Bay.

## 12. PRIZES

12.1. For each class, first prize will be awarded if at least three boats enter, second prize will be awarded if at least five boats enter, and third prize will be awarded if at least seven boats enter.

## 13. DISCLAIMER OF LIABILITY

13.1. The responsibility for a boat's decision to participate in a race or the continue racing is hers alone. See RRS Rule 4, Decision to Race. The organizing authority will not accept liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 14. INSURANCE

14.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$500,000 per event or the equivalent. A copy of certificate will be required at time of registration.
