# **NOTICE OF RACE**

#### 1. Rules

- 1.1 This regatta will be governed by the *rules* as defined in the *Racing Rules of Sailing*. Changes to these Rules may appear in the Sailing Instructions.
- 1.2 Regatta open to Sunfish only.
- 1.3 Rule changes: One turn penalty for violation of a *Rule* of Part II. The changes will appear in full in the sailing instructions. The sailing instructions may change other racing rules.
- 1.4 Changes to the NOR and/or SI's may be changed after a Lima flag and one horn.

#### 2. Eligibility and Entry

- 2.1 Open to all registrants of Class Sunfish boats. Please register through ww.regattanetwork.com. Registration & forms will also available at CCYC Tent at Hallie's Landing the morning of the Regatta (Sat April 26) no later than 10:00.
- 3. Fees

All entries: \$12

#### 4. Schedule of Races

Saturday, April 26, 2025 0800 - 0930 Registration at Hallie's Landing 10:00 Competitors' Meeting 11:00 First warning signal Awards to follow ASAP after last race

#### 5. Safety

Life jackets must be worn by all competitors shore to shore.

#### 6. Sailing Instructions

The Sailing Instructions will consist of the instructions in RRS Appendix S, Supplemental be available at registration.

#### 7. Courses

Courses will be windward-leeward or triangle; with modifications, as posted.

#### 8. Scoring

- 8.1 Four races are scheduled. A minimum of one race must be completed to constitute a regatta for that class.
- 8.2 When fewer than 4 races have been completed, a boat's series score will be the total of her race scores. There will be one drop if 5 races are completed.

#### 9. Prizes

Prizes will be awarded to the top 3 finishers. Other awards may be presented.

#### 10. Disclaimer of Liability

Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision to Race. Competitors are required to sign a waiver of liability. The waiver is in compliance with RRS 82.
